One application only shall be used for each candidate admitted during the academic year 2010-2011. **Photocopying of the application is not permitted and the application shall be submitted to this office only in its original format.** Unused applications shall be returned to this office indicating the serial numbers of the unused applications.

### **Admission Guidelines and Regulation and Syllabus for 2010-2011**

The Government of Tamil Nadu have issued Guidelines for admission to B.Ed Degree Course for the year 2010-2011 in G.O.Ms.No.182, Higher Education (G1) Department, dated 07.07.2010. These guidelines shall be followed by Government/Government Aided/Self-Financing Colleges offering B.Ed Degree Courses, strictly.

It is informed that admissions shall be made strictly in accordance with the guidelines prescribed by the Government of Tamil Nadu. The G.O has been published in the website [www.tnteu.in](http://www.tnteu.in) for your information and guidance for proceeding with the admissions.

The Syllabus and Regulations for B.Ed/M.Ed Degree Course for the academic year 2010-2011 are similar to Syllabus and Regulations prescribed for the year 2009-2010, already published in the University official website.

**It is reiterated that admission shall be made in accordance with the guidelines of the Government Order and as per the regulations prescribed by the University for the year 2010-2011.**

### **Last date for submission of filled in application to the University**

The last date prescribed by the University for Admission to B.Ed./M.Ed Degree course for the academic year 2010-2011 is **30.09.2010** and last date for submission of filled in applications for Approval of Admission to the University is **15.10.2010**.

### **Guidelines for submission of filled in application**

All the filled in applications shall be arranged in the alphabetical order and a list of applications shall be prepared. Duly filled in applications be consolidated as per the alphabetical order and handed over either in person or sent by registered post to the Registrar, Tamil Nadu Teachers Education University after consolidation and shall not be sent in piecemeal (i.e. on or before **15.10.2010**).

### **Payment of Fees**

The following fees shall be collected from the candidates at the time of admission and shall be sent to the University by means of Demand Draft drawn in favour of Registrar, Tamil Nadu Teachers Education University, Chennai-600 005.

The Fee shall be remitted in a single Demand Draft only for the actual number of candidates admitted to the course. No excess amount need be paid.

The Principals are requested to kindly sign the Application for Approval of Admission with College seal. It is also requested that Principal may kindly attest all the documents of the candidates submitted along with the applications, necessarily.

The Principals are further requested to kindly verify as to whether the dates of birth of the candidates and their names are written in the application forms as found in their 10<sup>th</sup>/S.S.L.C records. In the event of any change, it shall be supported by gazette notifications.

The candidates may also be strictly informed that electives/optionals once exercised shall not be changed under any circumstances. The irregular and incomplete applications shall be summarily rejected.
